<b>Financial Planning Fees</b>	Crafting a personalised financial plan to ensure your money lasts.	Lifestyle and goal setting, cash flow modelling, and financial advice.	Flat fee.	Upon completion of your Financial Plan.
<b>Estate Planning Fees</b>	Protecting and distributing your assets according to your wishes.	Will writing, Trust planning, Inheritance Tax strategies, and setting up a Lasting Power of Attorney.	Flat fee for each document prepared.	Upon successful completion and filing of estate planning documents.
<b>Investment Management Fees</b>	Managing your investments.	Portfolio design, risk assessment, rebalancing, and oversight.	0.30% per annum of assets under management.	Monthly, pro rata, from funds under advice.
<b>Platform or Custodian Fees</b>	Using the PlanHappy Platform to hold your investment assets.	Account maintenance, investment administration, transaction execution, and security.	From 0.27% per annum of assets under management.	Monthly, pro rata, from funds under advice.
<b>Fund Manager Charges</b>	Running costs of investment funds like unit trusts and ETFs.	Managing and administering the fund.	Percentage of funds under advice - varies depending on investments.	Monthly, pro rata, from funds under advice.
<b>Trading &amp; Transaction Fees</b>	Buying and selling investments.	Broker charges, fund dealing fees, and foreign exchange costs.	Per-trade fee or a percentage of the trade value.	At time of trade.
